Reducing network costs and enabling higher, more consistent network performance for end-users, as a coherent optimised system, it will also benefit the most from the improvements that coherent technology offers, today and well into the future.

Leveraging Ciena's programmable platforms, AEConnect will also be able to utilise emerging technologies, such as Software Defined Networking (SDN),



to support bandwidth-intensive applications. This ensures that global organisations can take advantage of resilient and secure connectivity at predictable costs.
